RULES & REGULATIONS

DATES : 9th-11th OCTOBER 2015
First match is on the 9th of October 2015 at 8:00AM.
Prize giving ceremony is on the 11th October before 12:00PM

MANAGERS MEETING : 8TH OCTOBER, 7 PM – MANAGERS MEETING

VENUE : SANDAKAN DISTRICT TENNIS ASSOCIATION

1. ITF and Bye Laws of Lawn Tennis Association of Malaysia (LTAM) shall apply.
2. **FORMAT** :
 - a. Each tie consists of 5 matches: 1 men's singles, 1 men's doubles, 1 men's veterans' singles, 1 men's veterans' doubles and 1 ladies doubles.
 - i. Men's category are for those in the age of 25 and above (Born in 1990 or before)
 - ii. Men's veterans are for those in the age of 45 and above (Born in 1970 or before)
 - iii. Ladies category are for those in the age of 35 and above (Born in 1980 or before)
 - iv. Players qualified for men's veteran's age group may register to play for the men's category but must remain playing ONLY for the men's category for the entire tournament.
 - v. Each player only plays 1 match per tie.
3. Each men's match will be completed either by
 - a. Winning 2 straight sets. (A normal tie break comes into operation if the score is 6-all).
 - b. A Super Tie break (10 Points) if it is 1 set ALL. A difference of two (2) points is needed to win the match i.e.13-11).
4. Each veteran's and ladies' match will be completed by
 - a. First to reach 8. (A normal tie break comes into operation if the score is 7-all; a difference of 2 points is needed to win the match i.e. 14-12).
5. **ORDER OF PLAY** :
 - a. Morning: Ladies Doubles, Veteran Doubles, Veteran Singles, Men's Doubles, Men's Singles
 - b. Afternoon: Men's Singles, Men's Doubles, Veteran Singles, Veteran Doubles and Ladies Doubles
6. In case of a tie on winning points; the deadlock shall be decided on the number of matches won, sets won, and games won (in that order). If there is still a tie, head-to-head results will be used.
7. The Line-up for each round shall be handed to the Honorary Referee at least fifteen minutes (15) minutes before play commences.
8. Umpires will NOT be provided. However, upon request the Honorary Referee or his representatives may consider providing one.

9. Appeals to the Honorary Referee shall be done immediately and shall only pertain to ITF and Tournament Rules.
10. The decisions of the Honorary Referee or his representative shall be FINAL.
11. Entrance fee is RM50.00 per team.
12. ***Closing date for registration is 1st September 2015.**
13. After the announcement of the matches, players shall report to the Secretariat. A fifteen (15) minutes grace period shall be given to late-comers after which a walkover shall be awarded to the opponent.
14. Only registered players and reserves are to be fielded. The number of players to be registered.
 - i. Maximum of 13 players
15. After the Line-up is handed to the Honorary Referee or his representatives, NO change of players is allowed.
16. Players who play in two 2 consecutive ties, will have a twenty 20 minutes rest before the next match.
17. Players are only given a five 5 minute warm-up before play begins.
